I'm pleased to provide this 2017 Annual Report to update you on the Owen Sound Regional Hospital Foundation's Caring for Tomorrow Endowment Fund.

The Foundation Board of Directors approved a \$478,000 disbursement from the Endowment for 2017 at its meeting on March 27. That afternoon, a cheque was presented to Lance Thurston, President and CEO of Grey Bruce Health Services. With this cheque, contributions to the hospital from the Fund total more than \$4.5 million since inception.

Gifts totalling \$218,981 were added to the Endowment during the year.

After a year-long review by its Fund Investment Committee, the Foundation decided that it was time to change investment managers. On May 1, Mawer Investment Management Ltd. assumed responsibility for investing assets of the Fund. Founded in 1974, Mawer (pronounced "More") has offices in Calgary, Toronto and Singapore. 150 employees manage more than \$48 billion for institutional and individual investors. In 2016, the 5 charitable foundations supporting GBHS hospitals embarked on a partnership to promote legacy and endowment giving. A new, shared position was created. This past January 1, I became GBHS 5 Foundations "Charitable Giving Advisor" and work to promote legacy giving on behalf of foundations in Centre Grey, Meaford, Owen Sound, Southampton and Bruce Peninsula.

Hospital Receives \$478,000 from Caring for Tomorrow Endowment Fund

March 27, 2018: Today, GBHS President & CEO Lance Thurston received \$478,000 from the Owen Sound Regional Hospital Foundation. The funds are proceeds from the Foundation's Caring for Tomorrow Endowment Fund for 2017.

The Foundation established its Endowment in 1996 to provide a secure, ongoing source of funding for new diagnostic and medical equipment. Hundreds of Will bequests and other gifts have been added to the Fund, where they are permanently invested. A portion of the income earned is what supports new equipment at the Hospital each year.

From a new histology processor and transfusion medicine fridge in the Laboratory, new endoscopes for general surgery, cardiac monitors, automated medication dispensing cabinets to new

anesthesia machines, the Endowment disbursement helped fund new medical equipment across eight different hospital departments. \$10,000 of the total was designated for clinical staff education & training.
